# Planning for relaxation of on-site COVID protocols

---

- Will roll back in sequence to monitor effect (weekly testing still in force for monitoring purposes)
- Communication to staff will be in one to two days
- Sequence
  - Mask mandate lifted starting Monday 3/21, except for <3 ft. distances (you can still wear a mask if you want, at any distance)
  - Future roll backs include less than weekly testing, daily health clearance, spacing requirements
- Maintaining Lab daily head count limit for now
- Maintaining conference room occupancy limits for now
  - Can meet unmasked if proper distance (>3 ft) and occupancy
  - HOWEVER, please respect others' wishes if requested to mask in a public setting
- For return to work, need a) Covid training if required for job, b) negative Covid test  $\leq 1$  week before return
  - Can be rapid test (take picture and send to J. Levine)
  - PCR test preferred
